*In any emergency situation, there are 2 major unique roles: **strategic** and **tactical**.*

*The **strategic** or management team which carries different names such as Emergency or Crisis Management Committee, etc. are decision makers who plan, develop procedures and in the event of crisis, ultimately decide when to activate emergency response procedures, evacuate the facility or shutdown operations. This is usually composed of the President or a senior executive and heads of relevant departments, i.e. human resources, security and safety, building management, finance, legal, transportation, etc.*

*The **tactical** team are the implementors who make sure procedures are followed according to instructions from the strategic group. Being on the ground, they are also responsible for providing feedback to management for them to make informed decisions. The team is led by an emergency coordinator who serves as link between the management committee and the response team.*

***PROTECT 2012** brings together these two groups in a conference designed to focus on their distinct roles and responsibilities. Based on the participant's responsibility or interest, he or she can choose which strategic sessions to attend. The plenary sessions provide the participants an understanding of how both roles will function and how they would interact in an emergency situation.*
